- Show the positive impact on health and/ or social care delivery. Examples include feedback received, number of beneficiaries and other relevant statistics.

SINGAPORE COMMUNITY ENGAGEMENT INITIATIVE AWARD





Before you start, ensure your nominee is leading a **neighbourhood-based** project/initiative*.

Write a **clear and direct statement** of the how your nominee has led a community programme or ground-up initiative to improve the overall well-being of the neighbourhood and state the cause(s) which the team is advocating. Where relevant, include details of partnership with the health and/or social care team/institution.

Provide **specific details** of the project/initiative. These should cover the following areas:

- 1. Effort in terms of how your nominee represented his/her community to address their health and/or social care needs, empowered them to take care of themselves and those around them and rallied them to lend their support;
- 2. Sustainability in terms of the number of years the project/initiative has been in place and the number of beneficiaries and volunteers supporting the community programme or ground-up initiative;
- 3. Health/social impact in terms of qualitative and quantitative results and its growth potential (i.e. scaling up of the programme/ initiative). Examples of results include feedback, survey findings, number of beneficiaries/volunteers and other relevant statistics.
