In keeping with Mr Tan Tock Seng's legacy of giving, Tan Tock Seng Hospital (TTSH) set up a charity arm, TTSH Endowment Fund (now known as TTSH Community Fund) in August 1995 to improve the quality of life of our patients and the community.

Our Charity disburses more than \$2 million each year to support over 2,000 needy patient cases, with a focus on the elderly.

From expensive non-standard medication to breathing equipment, mobility aids and dentures, TTSH Community Fund helps needy patients gain greater independence, improves their quality of life and enables them to integrate back into the community. Our Charity also supports healthcare research, innovation, and training for our staff and the community to deliver better patient care.

After being diagnosed with advanced nasopharyngeal cancer, Mr Cheong experienced a loss in independence. His sense of hearing and speech worsened, and he felt like he lost his role as a breadwinner, husband, and father. As a result, his mood was greatly affected and he became increasingly withdrawn. He was reluctant to engage in activities and was often seen lying in bed and staring into space.

Mr Cheong was first introduced to art therapy in September 2019 in an attempt to lift his spirits. He was initially hesitant, but eventually found himself inspired by abstract artworks.

As the weeks passed, Mr Cheong started looking forward to art therapy sessions and became more engaged with his speech, physio, and occupational therapists. From sitting out of bed to walking small distances with assistance, Mr Cheong was able to confidently navigate around independently, and found pleasure in creating art.

Mr Cheong's artwork tells an ongoing story of his healing and self-actualisation. In his younger days, he learnt art in school and used to draw on kitchen walls, wood, living room walls, and study tables.

During his stay in the hospital, Mr Cheong drew inspirations from his environment; from bedside curtains, flower motifs on tissue boxes and red packets, to postcards, magazines and physical photographs. He also found his personal style through the use of colour pencils, as this gave him a sense of control and satisfaction.



Community Rehabilitation Programme (CRP)

Rehabilitation is a crucial part of a patient's recovery. However, patients who are unable to afford rehabilitation therapies end up forgoing it.

CRP is a home rehabilitation service for low-income patients who are physically unable to access services in hospitals or day rehabilitation centres, and are not able to afford private home-based rehabilitation services.

CRP helps patients move around and integrate back into the community through home management and rehabilitation programmes tailored to their needs.



IWantToGoHome Fund

The IWanttoGoHome Fund (IWGH Fund) provides financial assistance to needy patients, for them to afford services and equipment required for timely discharge from the hospital. Some of these services and equipment include assistive and mobility devices, interim care services, medical consumables, transportation for discharge and medical appointments.



NCID Cares

HIV/AIDS affects patients both physically and emotionally. Besides having to cope with the physical impact of the virus that destroys their immune system, many patients also face discrimination and isolation due to the social stigma and myths associated with HIV/AIDS. NCID Cares looks after the physical and emotional well-being of HIV/AIDS patients and provides support for their families.

Helping ElderLy Patients (HELP)



Many of the needy patients under our Helping ElderLy Patients (HELP) Programme have no income, little savings, and limited family support. Our Programme helps these elderly patients aged 55 and above with out-of-pocket expenses such as adult diapers, wound dressings, nutrition, interim dialysis, mobility aids and dentures.

Programme of All Inclusive Care for the Terminally Ill (PACT)

PACT supports and cares for terminally ill patients and their families. We provide interim funding for the expenses needed to care for patients in their homes and daily lives. We also fund activities aimed at improving the quality of life of patients in palliative care, such as art therapy and music therapy sessions.

Ng Teng Fong Healthcare Innovation Programme

Ng Teng Fong Healthcare Innovation Programme (NTF HIP) was established through a generous gift of \$52 million from the family of the late Mr Ng Teng Fong to Tan Tock Seng Hospital (TTSH).

The aim of NTF HIP is to drive innovation in healthcare, to benefit and enhance the health of our patients and the population we serve. This programme takes a broad perspective and multi-level approach to drive innovation.

Since its inception in 2015, NTF HIP has funded training candidates, innovation projects, and community projects, all with positive outcomes. List below and on the following pages are some of the projects.

Track 1: Strategic Training

Project: Developing Clinical Staff's Capabilities for Managing Patients with Critical Physiological Derangements through Simulation-based Training

A simulation-based experimental training session was conducted for Medical Officers, residents, and students. This training develops capabilities required to manage patients with physiological derangements. Using a portable vital sign simulator, staff undergo in-situ simulation-based training to mimic real clinical environment.





Track 2: Innovation

Project: Emergency Department Interventions for the Frail Elderly (EDIFY)

EDIFY aims to pilot a protocol of comprehensive geriatric assessment on pre-frail to frail elderly persons at the Emergency Department (ED) so as to activate appropriate early intervention. This project has concluded, with promising results of reducing the number of preventable hospitalisation, as well as sustaining patient functionality with lower risk of adverse outcomes.

Track 3: Community Enabling

Changing Needs of Patient Care

Care and well-being consists of more than just physical health. To ensure that the needs of our patients are being met as a whole, we need to take a holistic, interdisciplinary approach to patient care.

CAPE

The Centre for Allied Health & Pharmacy Excellence (CAPE) was established to provide an exciting platform for spurring innovation, collaboration and training in integrating health and social care. CAPE aims to promote living independence and improve quality of life. We also hope to constantly innovate and improve our care models to anticipate and meet the demands of future needs. Since CAPE's launch, they have organised several events.




Track 4: Strategic Innovation

Ward Without Walls (WoW): Transforming Care Beyond Boundaries

Ward without Walls aims to transform inpatient care through digitalization, guided by three patientcentric thrusts, namely, Care Follows You; Anticipative Care by Your Side; and Empowered People, Empowered Decisions.



Clinic Without Walls (CoW): Care Anytime, Anywhere



Clinic without Walls leverages care redesign, digital technology and workforce transformation to deliver person-focused care across the care continuum - beyond the hospital walls and into the community. It aims to activate patients to own and manage their health, and enable them to access care on-the-go seamlessly, so that care follows the patients.

our funds and ensure we have enough resources to continue running existing programmes and support other operational needs. Major operating expenses such as administrative, manpower and operating costs are supported by our holding company, Tan Tock Seng Hospital Pte Ltd.

Our current year unrestricted funds (reserves) at \$7.2 million will only be able to fund about three years of projected annual operating expenditure.

The fund may selectively invest its reserves subject to:

- (a) Approval from the Board;
- (b) TTSH's/ NHG's financial policies and practices; and
- (c) MOHH's Common Investment Mandate and policy.

The Board reviews the amount of reserves on a yearly basis to ensure that there are adequate funds to support key charitable programmes and operational needs.
